## Keframa High School Sponsorship

Keframa High School was founded by two brothers and their father on family land about 10 miles east of Lira in N Uganda. The area had suffered for 25 years from rebel activity by the Lord's Resistance Army, a group who were not afraid to terrorise the local population and recruit children into their militia. Peace finally arrived in 2007 but the impact has been felt even up to now with many struggling orphans and people having ongoing land disputes.

The main occupation of the people in the region is subsistence farming and climate change is affecting yields severely with harvests being reduced and crops failing repeatedly over the recent few years.



Augustine and Jimmy Francis founded the school to give the poor students of the region an opportunity of a decent education. However, this presents a problem because many parents do not have the resources to pay any school fees.

Keframa has a higher proportion of girl students than is usual in Ugandan secondary schools.

Keframa School Build is a UK charity (number 1178686), which has been set up to fund the building and development of a good quality school to replace the current inadequate buildings. The school is run by the brothers, but accountable to the Anglican Diocese of Lango and is a not for profit organisation.
